

CFYHA Board of Directors Meeting Meeting Minutes

September 22, 2021

I. CALL TO ORDER

b) Fundraising Opportunities

- i) Amanda and Jordan Boss are working on T-shirt orders with a new company. They plan to order 115 shirts and take orders from players until 11/01/21.
 - (1) Katie will remove SquadLocker from the website as we no longer want to use them as a vendor.
- ii) It was suggested that we reach out to Chick-fil-A, Chipotle, Panera Bread, and Bubba's 33 for monthly fundraising opportunities.
- iii) Amanda is ordering \$250 in masks and \$250 in stickers and magnets to sell.
- iv) Val suggested compiling a *Rink Friendly Dinners* cookbook to sell as a fundraiser around Christmastime. She will reach out to FedEx for a quote per book.

c) Jersey Update

- i) We are no longer working with Five Hole this year.
- ii) New vendor: Hockey World out of Minnesota. So far they have been very responsive and estimate a two-week turnaround.
 - (1) The current travel jersey style is being retired. It would be beneficial to start thinking of what style the team would want for next year, NLT January 2022. Val suggested a camo pattern. It would be possible to choose two designs and let travel parents vote as they would need to purchase all new jerseys for the following season.

d) PEP-Development Program

- i) It was not brought to a vote but tabled as a program to consider next year.
- e) Marksmen

- No update at this time. Chris and Shanelle are still negotiating the contract with the Marksmen.
 - (1) Can we add an additional game for our 12U Rec team?
- ii) Chris will request Marky to make an appearance at the THFF event on 11/06/21.
- iii) Katie is waiting to hear back from the videographer. It is understood we need to have the 30-second advertisement completed NLT 10/30/21.
 - (1) If filming is conducted at games (possibly 10/16/21 and 10/17/21) a photo release form is required for participants from both teams who appear in the video.
