## **Meeting Minutes**

## March 13, 2024

I. Called to Order

Kelly O'Connell called to order the Board of Directors meeting of the Cape Fear Youth Hockey Association at 18:02 at Cleland Ice Rink.

#### II. Attendees

## III. Agenda

- a. Spring Hockey Jason McPhee said coaches are still needed, especially for 12/14U. The new board will want to decide if they want to keep the "advanced" Spring Hockey session based on registration numbers.
- b. Cleland Ice Rink closure Jason McPhee spoke to Col. Wilcox, he said the repair should take place July to September depending on when the equipment arrives. Jason McPhee, Kelly, Kristin, Tim, and Brian Taptick had a conference call with the Crown, they are willing to work with us to provide ice in case Cleland is closed longer than expected. There will be another conference call in the near future.
- c. Nicole logged into the Treasurer email and QuickBooks. She started working on getting things entered into QuickBooks correctly.
- d. Jasen stated that the last 3-year taxes should be done by the end of March.
- e. Jasen stated that all the reimbursements that needed to be mailed were mailed.

- g. Kelly brought up the unauthorized reimbursement the former treasure made to herself for her son's season due to several unrelated to hockey injuries for \$1,222 and the reimbursement she made to herself for two coaching certifications that were denied in October 2018 for a total of \$290. - for the last two weeks of the season since it was requested her son not return. Aaron will write a memorandum to add to the Cape Fear files detailing the situation.
